The Department is expecting all invited stakeholders to attend the roundtable on 23 September 2011.

Why has the AG decided to seek industry cooperation contemplating new laws while the main test case examining ISP liability for online copyright infringement (AFACT vs. iiNet) is still on appeal before Federal Courts?

Irrespective of the outcome of the litigation in the High Court, unauthorised file sharing will continue and will need to be addressed in some form.

It is the Government's preference to have an industry-based solution but will look closely at the outcomes of industry consultations and is open to considering other options should industry be unable to agree on a solution.
